

United Way of the Eastern Panhandle Unity Campaign 2023 Eligibility Criteria and Guidelines

These guidelines offer general guidance and are not a guarantee of application acceptance to the Unity Campaign of the Eastern Panhandle. Each application is evaluated on its potential value to the Eastern Panhandle; the quality of planning, leadership, support and vision expressed; and the relative need for the program proposed.

Eligibility:

Any 501(c)(3) non-profit organization, including schools and government agencies, that serve the West Virginia counties of Morgan, Berkeley and Jefferson are eligible to apply. Applications should align with United Way of the Eastern Panhandle's (UWEP) Impact Areas and Focus Issues. United Way's Impact Areas are Education, Financial Stability, Health and Basic Needs.

Organizations must comply with all regulations of the state, county and federal government pertaining to proper licensing, health and safety requirements and operation within the State of West Virginia. Organizations accepted into the Unity Campaign must also abide by the Fundraising Policies and Guidelines for the Unity Campaign, which outlines responsibilities and reporting requirements related to campaign funds.

Funding Considerations:

Permissible funding includes direct service costs and/or personnel costs associated with new, current or expansion of programs or projects as described in the submitted application.

Funding Priorities:

Proceeds from the 2023 Unity Campaign of the Eastern Panhandle will go to organizations that work in the areas of health, education, financial stability and basic needs. The 2023 Unity Campaign will support local nonprofits as a continued phase of pandemic recovery efforts.

Preference is given to projects or programs that:

- · Leverage funds in addition to any Campaign Funds
- Are collaborative projects or programs
- Utilize volunteers
- Demonstrate measurable outcomes
- Encourage more effective/innovative use of limited community resources
- Promote diversity, equity and inclusion in the Eastern Panhandle community

Funding requests will be considered for the following types of projects or programs:

- One-time: Immediate needs such as purchase of equipment and/or a specific initiative.
- On-going: Funding to continue an already established project or program

Limitations:

United Way cannot meet every community need. Unity Campaign funds are not for the following:

- After-the-fact support
- Operating deficits

Confidentiality:

Although the deliberations and discussions of the committee are strictly confidential, United Way staff will share information with other individuals and agencies as needed. To assist the applicant, United Way staff may discuss general concerns and questions with the applicant.

Decision-Making and Application Review Process:

Upon receipt of the completed applications, the requests will go through a community impact review process by UWEP. The UWEP Community Investment Committee is comprised of community leaders who volunteer their time on an annual basis to make investment recommendations to the full board of directors. As a steward of community dollars, United Way requires thorough evaluations of all requests received. The evaluation process may include requests for additional information. Final decisions on all applications rest with the United Way of the Eastern Panhandle Board of Directors.

Conflict of Interest Policy:

United Way of the Eastern Panhandle maintains a strict conflict of interest policy for its Board, staff and volunteers to ensure independence and integrity in its recommendations. Staff and volunteers may not accept any form of compensation, gifts or favors from any organization or representative that anticipates submitting an application to United Way or that has already submitted a proposal or has received United Way funding in the past.

Reporting Requirements:

United Way of the Eastern Panhandle requires accountability and transparency in all aspects of our operations. Organizations selected may be required to complete an outcome report form no later than December 31, 2023. In addition to the requested information, please consider including any additional information or material that you feel is relevant to the project. Consider including pictures of the event, news or media coverage and testimonials from participants. Completed reports will be submitted electronically to United Way.

Timeframe:

Applications to participate in the 2023 Unity Campaign will open on January 18. Applications will be due by midnight on January 27, 2023. An information session will be held January 18th.

United Way is required to fully review and evaluate all applications. Agencies will be notified of their pending approval status by January 31, 2023. <u>Final approval as a participating agency will be contingent on the mandatory attendance of Unity Campaign training on February 1st. A lack of requested information or an incomplete application would delay the decision-making and approval process. Attendance at the training is required for approval to participate.</u>
